## Stalking: Fear, facts and formulation

Stalking affects around 1 in 5 women and 1 in 20 men. Stalkers can be former partners, work- or school-mates, or strangers. Stalking is poorly understood by both the general public and by responding agencies. Unlike most crimes, stalking occurs over an extended period and is difficult to define. This expert day provides attendees with a deep understanding of stalking behaviour, why it occurs, its impact, and how best to address it.

The morning will begin by determining exactly what stalking behaviour is and the contexts in which it can occur. Myths will be challenged, and the relationship between stalking and other interpersonal crimes will be explored. The primary sub-types of stalkers will be presented, along with motivations for stalking and likely roots of stalking behaviour. Following this, we will reveal the impact that stalking has on its victims and third parties. Technology-facilitated stalking will then be explored.

The afternoon will focus on best responses in cases of stalking. Based on extensive research, Lorraine created a set of 11 screening questions that can help evaluate the likelihood of violence in stalking cases. A copy of the screening instrument and training on its use will be provided. This forms part of a broader focus on optimal interventions for both stalkers and victims, and determining general levels of risk and threat. Advice for investigators, supporters and victims will be provided, according to stalker sub-type.

Opportunities will be provided for participants to discuss relevant cases or issues that they have encountered. All content is informed by both research and best practice.

### Presenter's Details

Dr Lorraine Sheridan is a Chartered Forensic Psychologist from the UK who now lives and works in Australia. She completed Europe's first PhD on stalking and has published five books and more than 50 papers on the subject. Her research has taken an applied, interventionist angle. In the UK Lorraine was a police accredited offender profiler and she compiles psychological reports related to offenders, highlighting the risks posed by known or unknown suspects. She regularly gives case management advice to the police and other agencies about harassment, violence, risk assessment, threat assessment, malicious communications and similar topics. After a long stint as a senior academic in universities in the UK, Lorraine is now a Senior Lecturer at Curtin University in Perth. She is a founder member of the Association of European Threat Assessment Professionals and current President of the Asia Pacific Association of Threat Assessment Professionals. Her risk checklist for stalking has been adopted by most English and Welsh police forces and partner agencies.
